## Nanuet Public Library

Addendum to Patron Code of Conduct Due to the COVID-19 Pandemic

This Addendum has been created to ensure compliance with New York State health and safety procedures, and other pertinent guidelines from public health authorities during the COVID-19 pandemic.

Library patrons must agree to and comply with the following procedures before entering the Library building.

Any failure to so comply will result in prompt removal from the building.

## Effective Date of Addendum: 03/02/2022

This Addendum shall remain in effect until dissolved or withdrawn by the Board of Trustees

## A. You are PROHIBITED from entering the Library if:

- 1. You have any COVID-19-related symptoms, including, but not limited to fever, chills, cough, and/or shortness of breath; or
- 2. You have tested positive for COVID-19 in the past ten (10) days; or
- 3. You have been in close contact with someone who has been infected with COVID-19 in the past ten (10) days
- B. Face coverings are optional for staff and patrons, regardless of vaccination status.

- C. All individuals are encouraged to maintain at least six (6) feet of distance from others whenever possible.
- D. All individuals are encouraged to practice hand hygiene. Sanitizer, and public restrooms with soap and water are readily available throughout the building.
- E. There are no more time limits or capacity limits, other than those set by fire safety code.
- F. Five (5) public computers and one (1) Express computer are available for use on a walkin basis. Patrons must have a valid RCLS Library card to use a computer. No guest passes will be given except in special cases at the discretion of the Head of Adult Services.
- G. More computers may be put back into use at the discretion of the Library Director and Head of Adult Services if appropriate physical barriers/shields can be provided.
- H. Seating in the Adult/Teen Services floor is available, including study carrels and the Teen booth seating.

- I. The Children's Room is available on a walk-in basis.
- J. Toys, puzzles, and crafts are not available.
- K. The Storytelling Room remains closed to the public.
- L. Browsing, photocopying, faxing, scanning, and printing are available on a walk-in basis.
- M. Meeting rooms may be available for public use at limited capacity. Check with Library staff for updates.
- N. Maximum capacity for the Community Room is 40 people at a time.
- O. Library telephones are not available for public use.
- P. Adult/Teen Services floor is available to patrons in Grade 7 and above.
- Q. Children in Grades 6 and under must be accompanied by an adult.
- R. All rules and procedures must be followed completely and in all respects.
