Petition for nomination of candidate for office of member of the Board of Education in the Nanuet Union Free School District, New York.

Each member of a Board of Education of a Union Free School District shall have been a resident of the School District for at least one year prior to the election, and must be a qualified voter of the District. The qualifications for membership on a school board are:

- \* You must be able to read and write.
- \* You must be a qualified voter of the District (citizen of the U.S., at least 18 years of age and not a convicted felon or adjudged an incompetent).
- \* You must be and have been a resident of the District for at least one year prior to the election.
- \* You may not be a current employee of the school board.
- \* You cannot live in the same household with a family member who is also a member of the same school board.

According to New York State Education Law, nominating petitions must carry the signatures of at least 25 qualified voters or 2% of the total voters who cast ballots in the most recent General District Election, whichever is greater. The total number of ballots cast in 2025 was 620.

Accordingly, the required number of signatures to nominate for office in 2026 is 25.
